**RESOLUTION**

The revised schemes for grant of Cash Reward, Cash-in-lieu of Land & Lump Grant in-lieu of Annuity to the personnel of Indian Armed Forces from West Bengal, who are in receipt of Gallantry and Distinguished Service Awards were introduced vide Resolution Nos. 1967-HD dated 28.06.1989, 876-HD dated 12.08.1993 and 312-HD dated 22.04.1998.

2. A proposal for revision of Grant amount was under active consideration of the Govt. for some time past. After careful consideration of the proposal and in partial modification of the above referred Resolutions, the Governor is pleased to approve the Cash grant, Cash in-lieu of land and Lump grant in lieu of annuity to the following categories of Gallantry Awards and Distinguished Service Awards (Non-Gallantry) at the rates specified against each :

3. Grant in respect of other category of Awards & Distinguished Services, which are not mentioned in sl no. 2 above shall be guided by the existing Resolutions in this regard.

4. The terms & conditions prescribed in the existing Resolutions referred above shall apply in all cases.

5. This Resolution will take effect from the date of issue of the Resolution. Past cases settled otherwise shall not come under the purview of this scheme. Gallantry/Non-Gallantry Awards received prior to the date of issue of this Resolution shall be guided by the Resolution in force at the material time.

6. The D.D.O, Home & Hill Affairs Department will be the Drawing & Disbursing Officer in respect of the grant under the scheme.

7. These expenses for the grants under the scheme shall be met from the Head : '2075-Miscellaneous General Services-00-104-Pension & Awards in consideration of Distinguished Services-Non Plan-NP-003-Rewards for Gallantry to Defence Service Personnel [DF]-05-Rewards' under Demand No 68.

8. The Accountant General, West Bengal has been informed.




