B. Before it can be decided whether you are eligible for a pension, if, therefore, you consider you may be eligible for pension, you should complete this form and form MPC-60 (Revised) which is issued with it. Then return the form to controller of Defence Accounts (Pensions), Draupadi Ghat, Allalhabad-14, together with the following certificate: -

- (i) Your marriage certificate.
- (ii) Your birth certificate and that of your husband/wife.

(iii) If you do not have all the certificates, you should instead give the information asked for in Part –II.

C. If you find any difficulty in completing the forms you should write to or call at the address shown in Note 'B' above. Before signing the declaration at the end of the form please make sure that the questions have been answered correctly. This will save correspondence and delay. Please also note that this is an official document and that by making a statement which you know to be false you are committing a legal offence.






